INVITATION FOR SEALED BIDS FOR SOLAR STREET LIGHTS

Khireshwornath Municipality, Mahendranagar, Dhanusha invites sealed bids from eligible bidders for the design, supply, installation, testing and commissioning of solar street light. Eligible Bidders may obtain further information at office of the municipal executive. Telephone No: 041-540077

- 1. Qualification requirements include minimum required average annual turnover, experience in similar nature works, minimum number of essential requirement, qualification and experience of key professional staffs as specified in the bidding document. Other qualification requirement details can be obtained from Bidding Document and a complete set of bidding document may be purchased from the office of municipal executive by eligible bidders on the submission of a written application, on or before 17:00 hrs 2074/12/27 (10th April,2018) along with the copy of company/firm registration, business registration certificate, VAT registration certificate, tax clearance of fiscal year 2073/74, a proof of its enlistment in AEPC standing list and upon payment of a non-refundable fee mentioned below. Payment shall be in the form of cash at the office.
- 2. All bids shall be accompanied by a valid bid security of an amount not less than the amount as specified below. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. If the bidder wishes to submit the bid security in the form of cash, the bidder has to deposit cash in deposit account no: 1220303007104 of Kshireshwornath Municipality Office, Mahendranagar, Dhanusha in Nepal Rastriya Banijya Bank, Janakpur Branch, Dhanusha and shall submit bank deposit voucher along with the bid.
- 3. Bids must be delivered to the Office of Kshireshwornath Municipality, Mahendranagar, Dhanusha on or before 12:00 hrs of 11th April 2018 (28th Chaitra 2074). It will be opened at 14:00 hrs on the same date in the presence of bidder or their representatives. But their absence doesn't restrain in opening of the bid in the specified time.
- Bids shall be valid until 11th April 2018 (28th Chaitra 2074) and bid security shall remain valid at least up to 12th August 2018 (27th Shrawan 2075)
- If the specified date for last date of submission and opening falls on a Government holiday then the same time on the next working day shall be considered for such events. In such case the validity of bid security shall be considered from already specified last date for bid submission.
- 6. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
- 7. All other remaining things of the project will be according to prevailing acts and regulations.
